

# Linksafe Spot Checks




UBS implemented Linksafe in July 2022 to manage contractor compliance and safety. We are pleased to announce that Worker Spot Checks will be implemented from 1 October 2023 across all sites.

As the principal contractor, it is <u>your</u> responsibility to ensure that all your trades and employees have successfully completed the UBS induction <u>before</u> attending site.

#### LIMITED ASBESTOS REMOVAL WORK

In limited circumstances, UBS contractors can remove non-friable asbestoscontaining material without a licence. Unlicensed removal of non-friable asbestoscontaining material can only occur if:

- the area of asbestos-containing material to be removed does not exceed 10 square metres in total; and
- the total time taken to perform the asbestos removal work in any seven day period does not exceed one hour.
- This time period is cumulative carrying out unlicensed removal over a seven day period
- If unlicensed asbestos removal work is carried out, contractors have a number of obligations under the OHS

#### Regulations, including, but not limited to ensuring:

- Appropriate training of persons undertaking the removal must be completed and training records provided to UBS.
- Appropriate PPE must be worn.
- · Appropriately placed signs and barricades must be used
- Decontamination facilities must be provided for PPE and equipment
- So far as is reasonably practicable, that the work is performed in a way that eliminates the release of airborne asbestos fibres and prevents contamination of surrounding areas
- Asbestos waste is appropriately contained and disposed of;

# Electrical Safety Awareness is crucial to prevent accidents, injuries and fatalities in homes, workplaces, and public spaces.

- All electric tools and equipment MUST be inspected, tested, and tagged every 3 months and before use on construction sites.
- Connect electrical equipment to a protected outlet. Inspect switchboard on premises before commencing to verify that RCD is fitted and perform test to verify operation.
- Trades must provide portable safety switches if RCD is not fitted to switchboard or is not operating correctly.
- Trades must Inspect tools and check operation of controls daily before use.
- Faulty electric tools can not be used under any circumstances
